**Academic and Administrative Audit Report- 2019-20**

In response to the letter dated 03-08-2020, we the convener and members of AAA team have undertaken parameter wise assessment on 27-08-2020 and 28-08-2020. The following observations were made during the time of assessment. The IQAC Co-ordinator is informed to implement all the recommendations for the enhancement and sustenance of quality.

**Criterion I : Curricular Aspects**

Curricular Planning and Implementation	:	The senior teachers are involved in curriculum planning at the university level as BOS & BOE member. The teaching plan prepared need to be implemented rigorously.
Curriculum Enrichment	:	Few teachers are adopting ICT in teaching. Hence, all teachers need to explore ICT as a way of teaching in the classroom.
Feedback System	:	Feedback is collected and necessary action taken.

**Criterion II: Teaching—Learning and Evaluation**

Student Enrolment and Profile	:	Good.
Catering to Student Diversity	:	Good.
Teaching-Learning Process	:	Needs improvement by adopting latest pedagogical tools.
Teacher Quality	:	Good. A few number of teachers have Ph D. Other teachers also need to acquire higher qualifications. Teachers need to involve actively in research.
Evaluation Process and Reforms	:	Student evaluation quite good and transparent.
Student Performance and Learning Outcomes	:	Satisfactory. However, still higher performance can be achieved academically.

### **Criterion III: Research, Consultancy and Extension**

Promotion of Research	:	A system plan needs to be developed at the departmental level in this regard.
Resource Mobilization for Research	:	MRP & Projects are lacking.
Research Facilities	:	Science departments' laboratories need to be equipped with more infrastructures suitable for research activities.
Research Publications and Awards	:	Needs a drastic improvement. Few papers published.
Extension Activities and Institutional Social Responsibility	:	Average.
Collaboration	:	Good, but activities under MoUs & Collaborations need to be increased.

### **Criterion IV: Infrastructure and Learning Resources**

Physical Facilities	:	Good.
Library as a Learning Resource	:	Good. Special attention need to be given to improve the usage rate and automation need to be implemented.
IT Infrastructure	:	Needs improvement.
Maintenance of Campus Facilities	:	Satisfactory.

### **Criterion V: Student Support and Progression**

Student Mentoring and Support	:	Mentoring System to be implemented.
Student Progression	:	Needs improvement
Student Participation and Activities	:	Good.

### **Criterion VI: Governance, Leadership and Management**

Institutional Vision and Leadership	:	Good.
Strategy Development and Deployment	:	A time bound roadmap need to be communicated to all stakeholders.
Faculty Empowerment Strategies	:	Low.
Financial Management and Resource Mobilization	:	Need to identify funding agencies and make serious efforts to mobilize funds.
Internal Quality Assurance System	:	Active.

Environment Consciousness	:	Satisfactory.
Innovations	:	Lacking
Best Practices	:	Good.

## Recommendations

IQAC cell of the college is functioning in a systematic manner and is maintaining the records. Department level IQACs shall function in a pro-active manner and their activities shall be properly documented.

- It is desirable if the calendar of events prepared at the College level should include co-curricular and extra-curricular activities also.
- The college should take initiatives to attract more faculty members towards research by organizing workshops/awareness programs on research prospects and funding opportunities available. For this the college could associate with universities/UGC/CSIR/AICTE etc.
- It is observed that the college is having a well equipped central library. But the usage rate seems to be very low. Steps should be taken to improve this.
- Some departments have inadequate IT infrastructure (Computers & LCD projectors). This should be addressed at the earliest. Potential research departments shall be provided with necessary lab/ ICT facilities.
- Necessary safety measures including installation of fire extinguishers shall be ensured in laboratories.
- It is observed that there are no serious efforts taken to maintain data on student progression in the departments with documentary evidence. Efforts need to be taken to maintain documents related to student progression.
- The placement cell activities have to be strengthened. Efforts have to be taken to identify prospective employers and job fairs/ placement drives shall be conducted.




